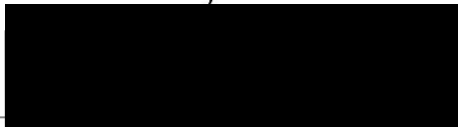

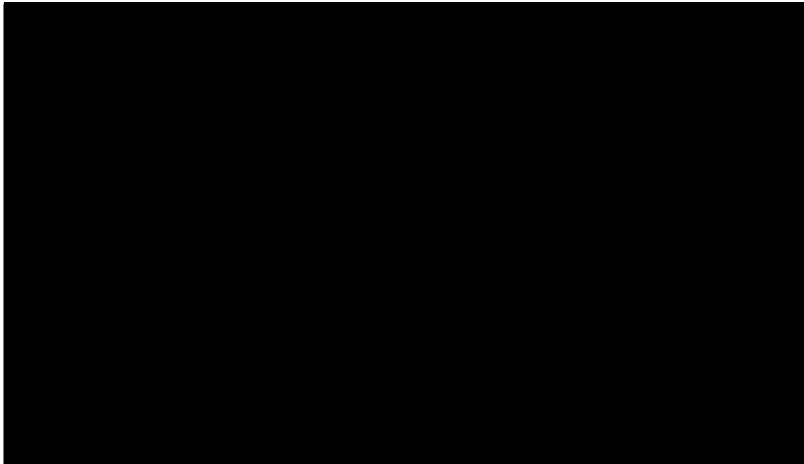

COUNT 1

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **PORSHA ROBINSON** with the offense of **IDENTITY FRAUD**, in violation of **O.C.G.A. § 16-9-121(a)(1)**, for that the said accused, in the County of Fulton and State of Georgia, on or about **August 28, 2021**, willfully and fraudulently, without authorization and consent, used with intent to fraudulently use identifying information concerning a person, to wit: the name of Demetrius Lester, contrary to the laws of said State, the good order, peace and dignity thereof.

The crime alleged does not fall outside of the limitations on prosecution because, pursuant to O.C.G.A. § 17-3-2(2), the crime was unknown until at least on or about February 2, 2022.

COUNT 2

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **PORSHA ROBINSON** with the offense of **FALSE STATEMENTS AND WRITINGS**, in violation of **O.C.G.A. § 16-10-20**, for that the said accused, in the County of Fulton and State of Georgia, on or about **August 28, 2021**, did knowingly and willfully make and use a false writing and document, to wit: an Emergency Rental Assistance tenant application, knowing the same to contain a false, fictitious, and fraudulent statement and entry, to wit: that rental assistance for Demetrius Lester was to be paid to PNC bank account x9599, in a matter within the jurisdiction of a department of state government, to wit: the Department of Community Affairs, contrary to the laws of said State, the good order, peace and dignity thereof.

Said rental assistance is further described as \$8,900.00 authorized in the name and on behalf of Demetrius Lester and instead directed to the accused's PNC bank account x9599.

The crime alleged does not fall outside of the limitations on prosecution because, pursuant to O.C.G.A. § 17-3-2(2), the crime was unknown until at least on or about February 2, 2022.

COUNT 3

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **PORSHA ROBINSON and DAVEON WILLIAMS** as a party to the crime or aiding and abetting with the offense of **FALSE STATEMENTS AND WRITINGS**, in violation of **O.C.G.A. § 16-10-20**, for that the said accused, in the County of Fulton and State of Georgia, on or about **October 28, 2021**, did knowingly and willfully make and use a false writing and document, to wit: an Emergency Rental Assistance tenant application, knowing the same to contain a false, fictitious, and fraudulent statement and entry, to wit: that Daveon Williams qualified for rental assistance, in a matter within the jurisdiction of a department of state government, to wit: the Department of Community Affairs, contrary to the laws of said State, the good order, peace and dignity thereof.

Said rental assistance is further described as \$29,960.00 authorized in the name and on behalf of Daveon Williams.

The crime alleged does not fall outside of the limitations on prosecution because, pursuant to O.C.G.A. § 17-3-2(2), the crime was unknown until at least on or about February 2, 2022.

COUNT 4

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **PORSHA ROBINSON and SEAN WIMBUSH** as a party to the crime or aiding and abetting with the offense of **FALSE STATEMENTS AND WRITINGS**, in violation of **O.C.G.A. § 16-10-20**, for that the said accused, in the County of Fulton and State of Georgia, on or about **November 3, 2021**, did knowingly and willfully make and use a false writing and document, to wit: an Emergency Rental Assistance tenant application, knowing the same to contain a false, fictitious, and fraudulent statement and entry, to wit: that Sean Wimbush qualified for rental assistance, in a matter within the jurisdiction of a department of state government, to wit: the Department of Community Affairs, contrary to the laws of said State, the good order, peace and dignity thereof.

Said rental assistance is further described as \$24,922.72 authorized in the name and on behalf of Sean Wimbush.

The crime alleged does not fall outside of the limitations on prosecution because, pursuant to O.C.G.A. § 17-3-2(2), the crime was unknown until at least on or about February 2, 2022.

COUNT 5

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **PORSHA ROBINSON** with the offense of **FALSE STATEMENTS AND WRITINGS**, in violation of **O.C.G.A. § 16-10-20**, for that the said accused, in the County of Fulton and State of Georgia, on or about **November 11, 2021**, did knowingly and willfully make and use a false writing and document, to wit: an Emergency Rental Assistance tenant application, knowing the same to contain a false, fictitious, and fraudulent statement and entry, to wit: that rental assistance for Antonia Grant was to be paid to

PNC bank account x2257, in a matter within the jurisdiction of a department of state government, to wit: the Department of Community Affairs, contrary to the laws of said State, the good order, peace and dignity thereof.

Said rental assistance is further described as \$24,950.00 authorized in the name and on behalf of Antonia Grant and instead directed to the accused's PNC bank account x2257.

The crime alleged does not fall outside of the limitations on prosecution because, pursuant to O.C.G.A. § 17-3-2(2), the crime was unknown until at least on or about February 2, 2022.

COUNT 6

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **PORSHA ROBINSON** with the offense of **FALSE STATEMENTS AND WRITINGS**, in violation of **O.C.G.A. § 16-10-20**, for that the said accused, in the County of Fulton and State of Georgia, on or about **November 12, 2021**, did knowingly and willfully make and use a false writing and document, to wit: an Emergency Rental Assistance tenant application, knowing the same to contain a false, fictitious, and fraudulent statement and entry, to wit: that rental assistance for Kenneth Robinson was to be paid to PNC bank account x4985, in a matter within the jurisdiction of a department of state government, to wit: the Department of Community Affairs, contrary to the laws of said State, the good order, peace and dignity thereof.

Said rental assistance is further described as \$23,200.00 authorized in the name and on behalf of Kenneth Robinson and instead directed to the accused's PNC bank account x4985.

The crime alleged does not fall outside of the limitations on prosecution because, pursuant to O.C.G.A. § 17-3-2(2), the crime was unknown until at least on or about February 2, 2022.

COUNT 7

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **PORSHA ROBINSON and DASHON HOLLOMAN** as a party to the crime or aiding and abetting with the offense of **FALSE STATEMENTS AND WRITINGS**, in violation of **O.C.G.A. § 16-10-20**, for that the said accused, in the County of Fulton and State of Georgia, on or about **November 21, 2021**, did knowingly and willfully make and use a false writing and document, to wit: an Emergency Rental Assistance tenant application, knowing the same to contain a false, fictitious, and fraudulent statement and entry, to wit: that Dashon Holloman qualified for rental assistance, in a matter within the jurisdiction of a department of state government, to wit: the Department of Community Affairs, contrary to the laws of said State, the good order, peace and dignity thereof.

Said rental assistance is further described as \$25,300.00 authorized in the name and on behalf of Dashon Holloman.

The crime alleged does not fall outside of the limitations on prosecution because, pursuant to O.C.G.A. § 17-3-2(2), the crime was unknown until at least on or about February 2, 2022.

COUNT 8

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **PORSHA ROBINSON and MIRANDA SHANESE PAYNE** as a party to the crime or aiding and abetting with the offense of **FALSE STATEMENTS AND WRITINGS**, in violation of **O.C.G.A. § 16-10-20**, for that the said accused, in the County of Fulton and State of Georgia, on or about **November 27, 2021**, did knowingly and willfully make and use a false writing and document, to wit: an Emergency Rental Assistance tenant application, knowing the same to contain a false, fictitious, and

fraudulent statement and entry, to wit: that Miranda Shanese Payne qualified for rental assistance, in a matter within the jurisdiction of a department of state government, to wit: the Department of Community Affairs, contrary to the laws of said State, the good order, peace and dignity thereof.

Said rental assistance is further described as \$25,750.00 authorized in the name and on behalf of Miranda Shanese Payne.

The crime alleged does not fall outside of the limitations on prosecution because, pursuant to O.C.G.A. § 17-3-2(2), the crime was unknown until at least on or about February 2, 2022.

COUNT 9

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **PORSHA ROBINSON and DAVIER LADMIRAULT** as a party to the crime or aiding and abetting with the offense of **FALSE STATEMENTS AND WRITINGS**, in violation of **O.C.G.A. § 16-10-20**, for that the said accused, in the County of Fulton and State of Georgia, on or about **November 29, 2021**, did knowingly and willfully make and use a false writing and document, to wit: an Emergency Rental Assistance tenant application, knowing the same to contain a false, fictitious, and fraudulent statement and entry, to wit: that Davier Ladmiraault qualified for rental assistance, in a matter within the jurisdiction of a department of state government, to wit: the Department of Community Affairs, contrary to the laws of said State, the good order, peace and dignity thereof.

Said rental assistance is further described as \$32,230.00 authorized in the name and on behalf of Davier Ladmiraault.

The crime alleged does not fall outside of the limitations on prosecution because, pursuant to O.C.G.A. § 17-3-2(2), the crime was unknown until at least on or about February 2,

2022.

COUNT 10

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **PORSHA ROBINSON** with the offense of **FALSE STATEMENTS AND WRITINGS**, in violation of **O.C.G.A. § 16-10-20**, for that the said accused, in the County of Fulton and State of Georgia, on or about **December 19, 2021**, did knowingly and willfully make and use a false writing and document, to wit: an Emergency Rental Assistance tenant application, knowing the same to contain a false, fictitious, and fraudulent statement and entry, to wit: that rental assistance for Cynthia Robinson was to be paid to PNC bank account x2193, in a matter within the jurisdiction of a department of state government, to wit: the Department of Community Affairs, contrary to the laws of said State, the good order, peace and dignity thereof.

Said rental assistance is further described as \$34,550.00 authorized in the name and on behalf of Cynthia Robinson and instead directed to the accused's PNC bank account x2193.

The crime alleged does not fall outside of the limitations on prosecution because, pursuant to O.C.G.A. § 17-3-2(2), the crime was unknown until at least on or about February 2, 2022.
