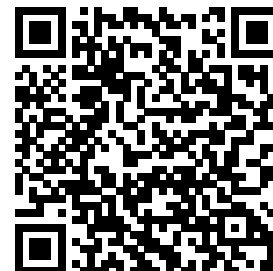

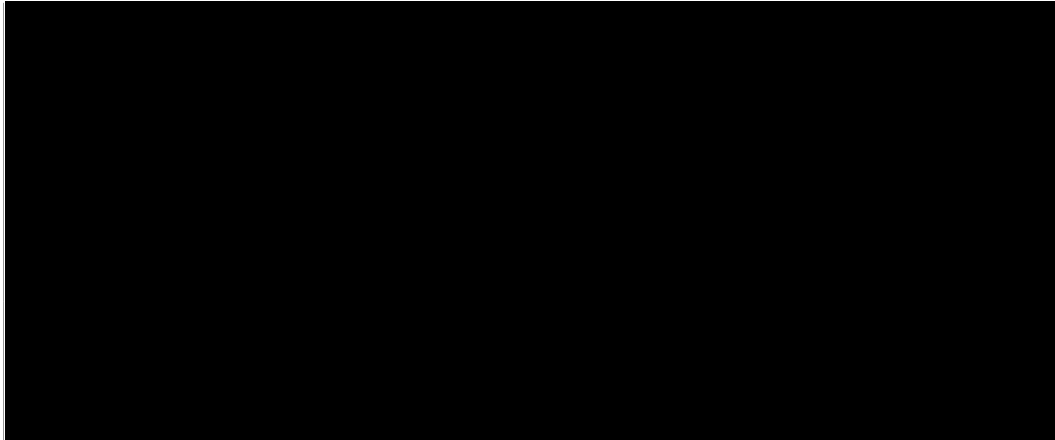

BILL OF INDICTMENT

IN THE SUPERIOR COURT OF SAID COUNTY,

THE GRAND JURORS selected, chosen and sworn for the County of Chatham to wit:



COUNT 1

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse, for that said accused, TREYVON KAIRH HOWARD a/k/a "SPINNZ", RASHINE JAMAL EDWARDS a/k/a "FROST", AND JAKARIE TYKELL COWELL a/k/a "JC" with the offense of VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT (O.C.G.A. 16-15-4(a)), for that the said accused, in the County and State aforesaid, on or about the 8th day of August, 2024, being associated with Rock Out Gang "ROG," a criminal street gang, did unlawfully participate in criminal gang activity through the commission of the offense of Aggravated Assault under O.C.G.A. 16-5-21, as outlined in Counts 10 through 11 of this Indictment, as enumerated in paragraph (1)(A) of Code Section 16-15-3, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 2

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse TREYVON KAIRH HOWARD a/k/a "SPINNZ", RASHINE JAMAL EDWARDS a/k/a "FROST", AND JAKARIE TYKELL COWELL a/k/a "JC" with the offense of VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT (O.C.G.A. 16-15-4(b)), for that the said accused, in the County and State aforesaid, on or about the 8th day of August, 2024, being associated with Rock Out Gang "ROG," a criminal street gang, did unlawfully participate in criminal gang activity through the commission of the offense of Aggravated Assault under O.C.G.A. 16-5-21, as set forth and described in Counts 10 through 11 of this Indictment, as enumerated in paragraph (1)(A) of Code Section 16-15-3, with the intent to maintain and increase their status in said gang, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 3

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse, for that said accused, **TREYVON KAIRH HOWARD a/k/a "SPINNZ" AND RASHINE JAMAL EDWARDS a/k/a "FROST"** with the offense of **VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT (O.C.G.A. 16-15-4(a))**, for that the said accused, in the County and State aforesaid, on or about the 10th day of August, 2024, being associated with Rock Out Gang "ROG," a criminal street gang, did unlawfully participate in criminal gang activity through the commission of the offense(s) of Hijacking a Motor Vehicle under O.C.G.A. 16-5-44.1, Armed Robbery under O.C.G.A. 16-8-41, and Financial Transaction Card Theft under O.C.G.A. 16-9-31(a)(1), as outlined in Counts 13, 14, and 16 of this Indictment, and enumerated in paragraph (1)(A) of Code Section 16-15-3, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 4

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **TREYVON KAIRH HOWARD a/k/a "SPINNZ" AND RASHINE JAMAL EDWARDS a/k/a "FROST"** with the offense of **VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT (O.C.G.A. 16-15-4(b))**, for that the said accused, in the County and State aforesaid, on or about the 10th day of August, 2024, being associated with Rock Out Gang "ROG," a criminal street gang, did unlawfully participate in criminal gang activity through the commission of Hijacking a Motor Vehicle under O.C.G.A. 16-5-44.1, Armed Robbery under O.C.G.A. 16-8-41, and Financial Transaction Card Theft under O.C.G.A. 16-9-31(a)(1), as outlined in Counts 13, 14, and 16 of this Indictment, and enumerated in O.C.G.A. 16-15-3(1)(A), with the intent to maintain and increase their status in said gang, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 5

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse, for that said accused, **TREYVON KAIRH HOWARD a/k/a "SPINNZ" AND RASHINE JAMAL EDWARDS a/k/a "FROST"** with the offense of **VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT O.C.G.A. § 16-15-4(c)**, for the said accused, in the County aforesaid, on or about the 10th day of August, 2024, while associated with Rock Out Gang "ROG," a criminal street gang, did unlawfully acquire and maintain, through criminal gang activity through the commission of Hijacking a Motor Vehicle under O.C.G.A. 16-5-44.1, Armed Robbery under O.C.G.A. 16-8-41, and Financial Transaction Card Theft under O.C.G.A. 16-9-31(a)(1), as outlined in Counts 13, 14, and 16 of this Indictment, and enumerated in O.C.G.A. 16-15-3(1)(A), a Toyota Highlander and a Financial Transaction Card, contrary to the laws of said State, the good order, peace and dignity thereof;

COUNT 6

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse, for that said accused, **JAKARIE TYKELL COWELL a/k/a "JC"** with the offense of **VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT (O.C.G.A. 16-15-4(a))**, for that the said accused, in the County and State aforesaid, on or about the 12th day of August, 2024, being associated with Rock Out Gang "ROG," a criminal street gang, did unlawfully participate in criminal gang activity through the commission of the offense of Possession of a Firearm by a Person under 18 Years of Age, (O.C.G.A. 16-11-132) in violation of O.C.G.A. 16-15-3(1)(J), by being a person under the age of 18 years, did possess and have under his control a firearm, a handgun, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 7

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse, for that said accused, **JAKARIE TYKELL COWELL a/k/a "JC"** with the offense of **VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT (O.C.G.A. 16-15-4(a))**, for that the said accused, in the County and State aforesaid, on or about the 12th day of August, 2024, being associated with Rock Out Gang "ROG," a criminal street gang, did unlawfully participate in criminal gang activity through the commission of the offense of Tampering with Evidence, (O.C.G.A. 16-10-94) in violation of O.C.G.A. 16-15-3(1)(A), by knowingly concealing and disguising physical evidence, a Smith and Wesson pistol, a firearm, said evidence involving the prosecution of the offenses of aggravated assault, hijacking a motor vehicle, armed robbery, possession of a handgun during the commission of a felony, and possession of a handgun by person under the age of 18 years, and criminal street gang activity, with intent to prevent the apprehension of the accused, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 8

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **JAKARIE COWELL a/k/a "JC"** with the offense of **VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT (O.C.G.A. 16-15-4(b))**, for that the said accused, in the County and State aforesaid, on or about the 12th day of August, 2024, being associated with Rock Out Gang "ROG," a criminal street gang, did unlawfully participate in criminal gang activity through the commission of the Possession of a Firearm by a Person under 18 Years of Age, (O.C.G.A. 16-11-132) in violation of O.C.G.A. 16-15-3(1)(J), by being a person under the age of 18 years, did possess and have under his control a firearm, a handgun, a Smith and Wesson pistol, a firearm, with the intent to maintain and increase his status in said gang, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 9

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **JAKAIRE COWELL a/k/a "JC"** with the offense of **VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT (O.C.G.A. 16-15-4(b))**, for that the said accused, in the County and State aforesaid, on or about the 12th day of August, 2024, being associated with Rock Out Gang "ROG," a Criminal street gang, did unlawfully participate in criminal gang activity through the commission of the offense of Tampering with Evidence, (O.C.G.A. 16-10-94) in violation of O.C.G.A. 16-15-3(1)(A), by knowingly concealing and disguising physical evidence, a Smith and Wesson pistol, a firearm, said evidence involving the prosecution of the offenses of aggravated assault, hijacking a motor vehicle, armed robbery, possession of a firearm during the commission of a felony, possession of a handgun by person under the age of 18 years, and criminal street gang activity, with intent to prevent the apprehension of the accused, and with the intent to maintain and increase his status in said gang, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 10

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse, for that said accused, **TREYVON KAIRH HOWARD a/k/a "SPINNZ", RASHINE JAMAL EDWARDS a/k/a "FROST", AND JAKARIE TYKELL COWELL a/k/a "JC"** with the offense of **AGGRAVATED ASSAULT (O.C.G.A. 16-5-21)**, for that the said accused, in the County and State aforesaid, on or about the 8th day of August, 2024, individually and as a party concerned in the commission of the crime, did make an assault upon the person of Hezekiah Daniels with a deadly weapon, a pistol, by pointing said pistol at said victim, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 11

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse, for that said accused, **TREYVON KAIRH HOWARD a/k/a "SPINNZ", RASHINE JAMAL EDWARDS a/k/a "FROST", AND JAKARIE TYKELL COWELL a/k/a "JC"** with the offense of **AGGRAVATED ASSAULT (O.C.G.A. 16-5-21)**, for that the said accused, in the County and State aforesaid, on or about the 8th day of August, 2024, individually and as a party concerned in the commission of the crime, did make an assault upon the person of Hezekiah Daniels with a firearm, an object which when used offensively against a person is likely to result in serious bodily injury, by striking Hezekiah Daniels about the face and head with said firearm, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 12

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse, for that said accused, **TREYVON KAIRH HOWARD a/k/a "SPINNZ", RASHINE JAMAL EDWARDS a/k/a "FROST", AND JAKARIE TYKELL COWELL a/k/a "JC"** with the offense of **POSSESSION OF FIREARM DURING COMMISSION OF A FELONY (O.C.G.A. 16-11-106)**, for that the said accused, in the County and State aforesaid, on or about the 8th day of August, 2024, individually and as a party concerned in the commission of the crime, did unlawfully have within arm's reach of his person a pistol, a firearm, during the commission of the crime of Aggravated Assault, felony, a crime involving the person of Hezekiah Daniels, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 13

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse, for that said accused, **TREYVON KAIRH HOWARD a/k/a "SPINNZ" AND RASHINE JAMAL EDWARDS a/k/a "FROST"** with the offense of **HIJACKING A MOTOR VEHICLE (O.C.G.A. 16-5-44.1)**, for that the said accused, in the County and State aforesaid, on or about the 10th day of August, 2024, individually and as a party concerned in the commission of the crime, did unlawfully obtain a Toyota Highlander, a motor vehicle, from the immediate presence of Mohammadaref Andar, by force and violence and intimidation, while in possession of a firearm, a handgun, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 14

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse, for that said accused, **TREYVON KAIRH HOWARD a/k/a "SPINNZ" AND RASHINE JAMAL EDWARDS a/k/a "FROST"** with the offense of **ARMED ROBBERY (O.C.G.A. 16-8-41)**, for that the said accused, in the County and State aforesaid, on or about the 10th day of August, 2024, individually and as a party concerned in the commission of the crime, with the intent to commit a theft, did unlawfully take a Toyota Highlander, property of Mohammadaref Andar, from the immediate presence of Mohammadaref Andar, by the use of a handgun, an offensive weapon, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 15

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse, for that said accused, **TREYVON KAIRH HOWARD a/k/a "SPINNZ"** with the offense of **POSSESSION OF FIREARM DURING COMMISSION OF A FELONY (O.C.G.A. 16-11-106)**, for that the said accused, in the County and State aforesaid, on or about the 10th day of August, 2024, did unlawfully have within arm's reach of his person a handgun, a firearm, during the commission of the crime of Hijacking a Motor Vehicle under O.C.G.A. 16-5-44.1 and Armed Robbery under O.C.G.A. 16-8-41, as outlined in Counts 13 through 14 of this Indictment, a felony, a crime involving the person of Mohammadaref Andar, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 16

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse, for that said accused, **TREYVON KAIRH HOWARD a/k/a "SPINNZ" AND RASHINE JAMAL EDWARDS a/k/a "FROST"** with the offense of **FINANCIAL TRANSACTION CARD THEFT (O.C.G.A. 16-9-31(a)(1))**, for that the said accused, in the County and State aforesaid, on or about the 10th day of August, 2024, individually and as a party concerned in the commission of the crime, did unlawfully take and withhold a Wells Fargo Card, a financial transaction card issued to Mohammadaref Andar as the cardholder, without the consent of said cardholder, from whose control the card was withheld, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 17

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse, for that said accused, **RASHINE JAMAL EDWARDS a/k/a "FROST"** with the offense of **VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT (O.C.G.A. 16-15-4(a))**, for that the said accused, in the County and State aforesaid, on or about the 8th day of August, 2024 through the 12th day of August, 2024, being associated with Rock Out Gang "ROG," a criminal street gang, did unlawfully participate in criminal gang activity through the commission of the offense of Possession of a Firearm by a First Offender Probationer, as outlined in Count 19 of this Indictment, as enumerated in paragraph (1)(J) of Code Section 16-15-3, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 18

THE GRAND JURORS AFORESAID, AND SWORN FOR THE COUNTY OF CHATHAM, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **RASHINE JAMAL EDWARDS a/k/a "FROST"** with the offense of **VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT (O.C.G.A. 16-15-4(b))**, for that the said accused, in the County and State aforesaid, on or about the 8th day of August, 2024 through the 12th day of August, 2024, being associated with Rock Out Gang "ROG," a criminal street gang, did unlawfully participate in criminal gang activity through the commission of the offense of Possession of a Firearm as a First Offender Probationer, as outlined in Count 19 of this Indictment, with the intent to maintain and increase his status in said gang, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 19

THE GRAND JURORS AFORESAID, CHOSEN AND SWORN FOR THE COUNTY OF CHATHAM IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse, for that said accused, **RASHINE JAMAL EDWARDS a/k/a "FROST"** with the offense of **POSSESSION OF FIREARM BY FIRST OFFENDER PROBATIONER (O.C.G.A. 16-11-131(b))**, for that the said accused, in the County and State aforesaid, on or about the 8th day of August, 2024 through the 12th day of August, 2024, did, knowingly and without lawful authority, possess a firearm, a handgun, while on probation as a felony first offender, Case Number 22CR01092-B, Douglas Superior Court, State of Georgia, for the offense of Theft by Receiving Stolen Property, contrary to the laws of said State, the good order, peace and dignity thereof.
