The Grand Jurors, aforesaid, selected, chosen, and sworn for the County of Harris, in the name and on behalf of the citizens of Georgia, charge and accuse **DEANDRE "TUCK" TUCKER, JAIME "UZI" MOORE, JACOBY "K5" HUDSON, and JEREMIAH "BABYSNAKE" BRIDGES**, individually and as parties concerned in the commission of a crime, with the offense of **Violation of Street Gang Terrorism and Prevention Act O.C.G.A. 16-15-4(a)**, in that the said accused, in said State and said County, on or about the 3rd day of November, 2023, did unlawfully, while associated with the Bloods, a criminal street gang, participate in criminal gang activity through the commission of the offense of Home Invasion - 1st Degree as alleged in Count 7 of this Indictment and Attempted Armed Robbery as alleged in Count 8 of this Indictment, contrary to the laws of said State, the good order, peace, and dignity thereof.

COUNT 2

And the Grand Jurors, aforesaid, selected, chosen, and sworn for the County of Harris, in the name and on behalf of the citizens of Georgia, do further charge and accuse **DEANDRE "TUCK" TUCKER, JAIME "UZI" MOORE, JACOBY "K5" HUDSON, and JEREMIAH "BABYSNAKE" BRIDGES**, individually and as parties concerned in the commission of a crime, with the offense of **Violation of Street Gang Terrorism and Prevention Act O.C.G.A. 16-15-4(a)**, in that the said accused, in said State and said County, on or about the 3rd day of November, 2023, did unlawfully, while associated with the Bloods, a criminal street gang, participate in criminal gang activity through the commission of the offense of Aggravated Assault as alleged in Counts 9 and 10 of this Indictment and Aggravated Battery as alleged in Count 11 of this Indictment, contrary to the laws of said State, the good order, peace, and dignity thereof.

And the Grand Jurors, aforesaid, selected, chosen, and sworn for the County of Harris, in the name and on behalf of the citizens of Georgia, do further charge and accuse **JAIME "UZI" MOORE** with the offense of **Violation of Street Gang Terrorism and Prevention Act O.C.G.A. 16-15-4(a)**, in that the said accused, in said State and said County, on or about the 3rd day of November, 2023, did unlawfully, while associated with the Bloods, a criminal street gang, participate in criminal gang activity through the commission of the offense of Possession of a Firearm by a Convicted Felon as alleged in Count 15 of this Indictment, contrary to the laws of said State, the good order, peace, and dignity thereof.

COUNT 4

And the Grand Jurors, aforesaid, selected, chosen, and sworn for the County of Harris, in the name and on behalf of the citizens of Georgia, do further charge and accuse **JAIME "UZI" MOORE, JACOBY "K5" HUDSON, and JEREMIAH "BABY SNAKE" BRIDGES**, individually and as parties concerned in the commission of a crime, with the offense of **Violation of Street Gang Terrorism and Prevention Act O.C.G.A. 16-15-4(b)**, in that the said accused, in said State and said County, on or about the 3rd day of November, 2023, did unlawfully, while associated with the Bloods, a criminal street gang, participate in criminal gang activity through the commission of the offense of Home Invasion - 1st Degree as alleged in Count 7 of this Indictment and Attempted Armed Robbery as alleged in Count 8 of this Indictment, with the intent to maintain or increase his status or position in the aforesaid gang, contrary to the laws of said State, the good order, peace, and dignity thereof.

And the Grand Jurors, aforesaid, selected, chosen, and sworn for the County of Harris, in the name and on behalf of the citizens of Georgia, do further charge and accuse **JAIME “UZI” MOORE, JACOBY “K5” HUDSON, and JEREMIAH “BABY SNAKE” BRIDGES**, individually and as parties concerned in the commission of a crime, with the offense of **Violation of Street Gang Terrorism and Prevention Act O.C.G.A. 16-15-4(b)**, in that the said accused, in said State and said County, on or about the 3rd day of November, 2023, did unlawfully, while associated with the Bloods, a criminal street gang, participate in criminal gang activity through the commission of the offense of Aggravated Assault as alleged in Counts 9 and 10 of this Indictment and Aggravated Battery as alleged in Count 11 of this Indictment, with the intent to maintain or increase his status or position in the aforesaid gang, contrary to the laws of said State, the good order, peace, and dignity thereof.

COUNT 6

And the Grand Jurors, aforesaid, selected, chosen, and sworn for the County of Harris, in the name and on behalf of the citizens of Georgia, do further charge and accuse **JAIME “UZI” MOORE** with the offense of **Violation of Street Gang Terrorism and Prevention Act O.C.G.A. 16-15-4(b)**, in that the said accused, in said State and said County, on or about the 3rd day of November, 2023, did unlawfully, while associated with the Bloods, a criminal street gang, participate in criminal gang activity through the commission of the offense of Possession of a Firearm by a Convicted Felon as alleged in Count 15 of this Indictment, with the intent to maintain or increase his status or position in the aforesaid gang, contrary to the laws of said State, the good order, peace, and dignity thereof.

COUNT 7

And the Grand Jurors, aforesaid, selected, chosen, and sworn for the County of Harris, in the name and on behalf of the citizens of Georgia, do further charge and accuse **DEANDRE “TUCK” TUCKER, JAIME “UZI” MOORE, JACOBY “K5” HUDSON, and JEREMIAH “BABY SNAKE” BRIDGES**, individually and as parties concerned in the commission of a crime, with the offense of **Home Invasion in the First Degree O.C.G.A. 16-7-5**, in that the said accused, in said State and said County, on or about the 3rd day of November, 2023, without authority and with intent to commit Armed Robbery, a forcible felony, therein and while in possession of a handgun, a deadly weapon, did enter the dwelling house of Tredijimon Terry while such dwelling house was occupied by Tredijimon Terry, a person with authority to be present therein, contrary to the laws of said State, the good order, peace, and dignity thereof.
