THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse JADEN “JAY SAVAGE” APPLING, ANTHONY “NICK” BROWN, XZYDRIC “SUN SUN” FAUST and GLENDARIUS “GLEN” TATE with the offense of VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT O.C.G.A. § 16-15-4(a), for that the said accused, in the County and State aforesaid, on the 5th day of March, 2023, being associated with Everybody Killa, a criminal street gang, did unlawfully participate in criminal gang activity through the commission of the offense of Felony Murder as alleged in Count 3 of this Indictment, Aggravated Assault as alleged in Count 4 of this Indictment, Criminal Damage to Property in the First Degree as alleged in Count 5 of this Indictment, and Possession of Firearm During Commission of a Felony as alleged in Count 6 of this Indictment, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 2

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **JADEN "JAY SAVAGE" APPLING, ANTHONY "NICK" BROWN, XZYDRIC "SUN SUN" FAUST and GLENDARIUS "GLEN" TATE** with the offense of **VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT O.C.G.A. § 16-15-4(b)**, for that the said accused, in the County and State aforesaid, on the 5th day of March, 2023, being associated with Everybody Killa, a criminal street gang, did unlawfully participate in criminal gang activity through the commission of the offense of Felony Murder as alleged in Count 3 of this Indictment, Aggravated Assault as alleged in Count 4 of this Indictment, Criminal Damage to Property in the First Degree as alleged in Count 5 of this Indictment, and Possession of Firearm During Commission of a Felony as alleged in Count 6 of this Indictment, with the intent to maintain or increase his status or position in said gang, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 3

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **JADEN "JAY SAVAGE" APPLING, ANTHONY "NICK" BROWN, XZYDRIC "SUN SUN" FAUST and GLENDARIUS "GLEN" TATE**, individually and as parties concerned in the commission of a crime, with the offense of **FELONY MURDER O.C.G.A. § 16-5-1(c)**, for that the said accused, in the County and State aforesaid, on the 5th day of March, 2023, did unlawfully, and irrespective of malice, cause the death of Ja'Vanni McDavid, a human being, while in the commission of a felony, to wit: Aggravated Assault and Criminal Damage to Property in the First Degree, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 4

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **JADEN "JAY SAVAGE" APPLING, ANTHONY "NICK" BROWN, XZYDRIC "SUN SUN" FAUST and GLENDARIUS "GLEN" TATE**, individually and as parties concerned in the commission of a crime, with the offense of **AGGRAVATED ASSAULT O.C.G.A. § 16-5-21**, for that the said accused, in the County and State aforesaid, on the 5th day of March, 2023, did make an assault upon the person of Ja'Vanni McDavid with a deadly weapon, to wit: a firearm, by shooting at, toward, and in the direction of Ja'Vanni McDavid, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 5

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **JADEN "JAY SAVAGE" APPLING, ANTHONY "NICK" BROWN, XZYDRIC "SUN SUN" FAUST and GLENDARIUS "GLEN" TATE**, individually and as parties concerned in the commission of a crime, with the offense of **CRIMINAL DAMAGE TO PROPERTY IN THE FIRST DEGREE O.C.G.A. § 16-7-22**, for that the said accused, in the County and State aforesaid, on the 5th day of March, 2023, did knowingly and without authority interfere with a white Honda Accord, Georgia tag TAD 8296, the property of Ja'Vanni McDavid, in a manner so as to endanger the human life of Ja'Vanni McDavid by shooting a firearm in the direction of and striking said Honda Accord, knowing that said Honda Accord was occupied, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 6

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **JADEN "JAY SAVAGE" APPLING, ANTHONY "NICK" BROWN, XZYDRIC "SUN SUN" FAUST and GLENDARIUS "GLEN" TATE**, individually and as parties concerned in the commission of a crime, with the offense of **POSSESSION OF FIREARM DURING COMMISSION OF A FELONY O.C.G.A. § 16-11-106**, for that the said accused, in the County and State aforesaid, on the 5th day of March, 2023, did unlawfully have on or within arm's reach of his person a firearm during the commission of a felony, to wit: Felony Murder, Aggravated Assault, and Criminal Damage to Property in the First Degree, crimes involving the person of Ja'Vanni McDavid, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 7

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse **ANTHONY "NICK" BROWN** with the offense of **DRIVING WHILE LICENSE SUSPENDED O.C.G.A. § 40-5-75**, for that the said accused, in the County and State aforesaid, on the 5th day of March, 2023, did operate a motor vehicle on a public highway of the State of Georgia at a time in which his privilege to drive had been suspended, contrary to the laws of said State, the good order, peace and dignity thereof.
