The Grand Jurors aforesaid, chosen and sworn for the County of Richmond in the name and on behalf of the citizens of Georgia further charge and accuse **CAM'RON LAMONT BARBER HARRIS AND TYLER LAMONT PRESTON** with the offense of **VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT (O.C.G.A. 16-15-4(a))**, for that the said accused, in the County of Richmond and the State of Georgia, on the 22nd day of May, 2025, being associated with Extort Anybody ("EA"), a criminal street gang, did unlawfully participate in criminal gang activity through the commission of the offenses of Murder and Felony Murder under O.C.G.A. 16-5-1 as set forth and described in Counts 9 and 10 of this Indictment and Aggravated Assault under O.C.G.A. 16-5-21 as set forth and described in Counts 11, 13, and 15 of this Indictment, contrary to the laws of said State, the good order, peace and dignity thereof.

## COUNT 2

### COUNT 31

The Grand Jurors aforesaid, chosen and sworn for the County of Richmond in the name and on behalf of the citizens of Georgia further charge and accuse **ZMERR DENT, CHRISTOPHER FITZGERALD MORTON AND JAMONTAE JAMAAL DOUGLAS** with the offense of **VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT (O.C.G.A. 16-15-4(b))**, for that the said accused, in the County of Richmond and the State of Georgia, on the 22nd day of May, 2025, being associated with Extort Anybody ("EA"), a criminal street gang, did unlawfully participate in criminal gang activity through the commission of the offense of Tampering with Evidence under O.C.G.A. 16-10-94 as set forth and described in Count 32 of this Indictment, with the intent to maintain and increase their status in said gang, contrary to the laws of said State, the good order, peace and dignity thereof.

### COUNT 32

The Grand Jurors aforesaid, chosen and sworn for the County of Richmond in the name and on behalf of the citizens of Georgia further charge and accuse **ZMERR DENT, CHRISTOPHER FITZGERALD MORTON AND JAMONTAE JAMAAL DOUGLAS** with the offense of **TAMPERING WITH EVIDENCE (O.C.G.A. 16-10-94)**, for that the said accused, in the County of Richmond and the State of Georgia, on the 22nd day of May, 2025, did knowingly conceal physical evidence, to wit: firearms, said evidence involving the prosecution of the offense of Murder, a serious felony as defined in subsection (a) of Code Section 17-10-6.1 of the Official Code of Georgia, with intent to obstruct the prosecution of Cam'ron Barber Harris and Tyler Preston, other persons, contrary to the laws of said State, the good order, peace and dignity thereof.

### COUNT 33

The Grand Jurors aforesaid, chosen and sworn for the County of Richmond in the name and on behalf of the citizens of Georgia further charge and accuse **ZMERR DENT AND CHRISTOPHER FITZGERALD MORTON** with the offense of **VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT (O.C.G.A. 16-15-4(a))**, for that the said accused, in the County of Richmond and the State of Georgia, on the 5th day of June, 2025, being associated with Extort Anybody ("EA"), a criminal street gang, did unlawfully participate in criminal gang activity through the commission of the offense of Possession of Marijuana with Intent to Distribute under O.C.G.A. 16-13-30(j) as set forth and described in Count 35 of this Indictment, contrary to the laws of said State, the good order, peace and dignity thereof.

### COUNT 34

The Grand Jurors aforesaid, chosen and sworn for the County of Richmond in the name and on behalf of the citizens of Georgia further charge and accuse **ZMERR DENT AND CHRISTOPHER FITZGERALD MORTON** with the offense of **VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT (O.C.G.A. 16-15-4(b))**, for that the said accused, in the County of Richmond and the State of Georgia, on the 5th day of June, 2025, being associated with Extort Anybody ("EA"), a criminal street gang, did unlawfully participate in criminal gang activity through the commission of the offense of Possession of Marijuana with Intent to Distribute under O.C.G.A. 16-13-30(j) as set forth and described in Count 35 of this Indictment, with the intent to maintain and increase their status in said gang, contrary to the laws of said State, the good order, peace and dignity thereof.

### COUNT 35

The Grand Jurors aforesaid, chosen and sworn for the County of Richmond in the name and on behalf of the citizens of Georgia further charge and accuse **ZMERR DENT AND CHRISTOPHER FITZGERALD MORTON** with the offense of **POSSESSION OF MARIJUANA WITH INTENT TO DISTRIBUTE (O.C.G.A. 16-13-30(j))**, for that the said accused, in the County of Richmond and the State of Georgia, on the 5th day of June, 2025, did unlawfully possess, with the intent to distribute, Marijuana, in violation of the Georgia Controlled Substances Act, which violation constitutes a felony as provided for in O.C.G.A. 16-13-30(j)(2), contrary to the laws of said State, the good order, peace and dignity thereof.

### COUNT 36

The Grand Jurors aforesaid, chosen and sworn for the County of Richmond in the name and on behalf of the citizens of Georgia further charge and accuse **CHRISTOPHER FITZGERALD MORTON** with the offense of **VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT (O.C.G.A. 16-15-4(a))**, for that the said accused, in the County of Richmond and the State of Georgia, on the 22nd day of May, 2025, being associated with Extort Anybody ("EA"), a criminal street gang, did unlawfully participate in criminal gang activity through the commission of the offense of Possession of a Firearm by a First Offender Probationer under O.C.G.A. 16-11-131(b) as set forth and described in Count 38 of this Indictment, contrary to the laws of said State, the good order, peace and dignity thereof.

### COUNT 37

The Grand Jurors aforesaid, chosen and sworn for the County of Richmond in the name and on behalf of the citizens of Georgia further charge and accuse **CHRISTOPHER FITZGERALD MORTON** with the offense of **VIOLATION OF STREET GANG TERRORISM AND PREVENTION ACT (O.C.G.A. 16-15-4(b))**, for that the said accused, in the County of Richmond and the State of Georgia, on the 22nd day of May, 2025, being associated with Extort Anybody ("EA"), a criminal street gang, did unlawfully participate in criminal gang activity through the commission of the offense of Possession of a Firearm by a First Offender Probationer under O.C.G.A. 16-11-131(b) as set forth and described in Count 38 of this Indictment, with the intent to maintain and increase his status in said gang, contrary to the laws of said State, the good order, peace and dignity thereof.

**COUNT 38**

The Grand Jurors aforesaid, chosen and sworn for the County of Richmond in the name and on behalf of the citizens of Georgia further charge and accuse **CHRISTOPHER FITZGERALD MORTON** with the offense of **POSSESSION OF FIREARM BY FIRST OFFENDER PROBATIONER (O.C.G.A. 16-11-131(b))**, for that the said accused, in the County of Richmond and the State of Georgia, on the 22nd day of May, 2025, while on probation as a first offender pursuant to Article 3 of Chapter 8 of Title 42 of the Official Code of Georgia Annotated imposed by a court of competent jurisdiction, for a felony under the laws of the State of Georgia, did possess/transport a handgun, a firearm, contrary to the laws of said State, the good order, peace and dignity thereof.
