COUNT 3

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse KALIP "DON MAN" SHERMAN with the offense of POSSESSION OF MARIJUANA WITH INTENT TO DISTRIBUTE O.C.G.A. 16-13-30(j), for that the said accused, in the County and State aforesaid, on the 13th day of March, 2022, did unlawfully possess marijuana with the intent to distribute, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 4

THE GRAND JURORS AFORESAID, IN THE NAME AND BEHALF OF THE CITIZENS OF GEORGIA, charge and accuse KALIP "DON MAN" SHERMAN with the offense of POSSESSION OF METHAMPHETAMINE O.C.G.A. 16-13-30(a), for that the said accused, in the County and State aforesaid, on the 13th day of March, 2022, did unlawfully possess Methamphetamine, a Schedule II controlled substance, in violation of the Georgia Controlled Substances Act, contrary to the laws of said State, the good order, peace and dignity thereof.
