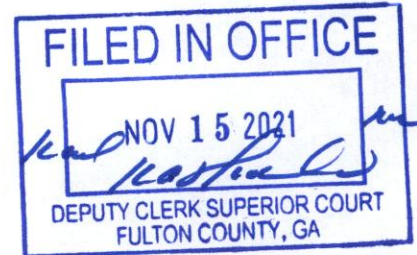

Count 1

On behalf of the people of the State of Georgia, the undersigned, as prosecuting attorney for the State aforesaid, does hereby charge and accuse **BERNARD C. KABA** with the offense of **THEFT BY TAKING**, in violation of **O.C.G.A. § 16-8-2**, for that the said accused, in the County of Fulton and the State of Georgia, on or about September 23, 2020, unlawfully did take money of a value exceeding \$24,999.99, to wit, \$137,220.13, further described as the funds transferred by transaction number 20200923-00010629, the property of Asset Living, with the intention of depriving the owner of this property, contrary to the laws of said State, the good order, peace, and dignity thereof.

Count 2

On behalf of the people of the State of Georgia, the undersigned, as prosecuting attorney for the State aforesaid, does further charge and accuse **BERNARD C. KABA** with the offense of **THEFT BY TAKING**, in violation of **O.C.G.A. § 16-8-2**, for that the said accused, in the County of Fulton and the State of Georgia, on or about September 23, 2020, unlawfully did take money of a value exceeding \$24,999.99, to wit, \$37,993.93, further described as the funds transferred by transaction number 20200923-00011453, the property of Asset Living, with the intention of depriving the owner of this property, contrary to the laws of said State, the good order, peace, and dignity thereof.

Count 3

On behalf of the people of the State of Georgia, the undersigned, as prosecuting attorney for the State aforesaid, does further charge and accuse **BERNARD C. KABA** with the offense of **THEFT BY TAKING**, in violation of **O.C.G.A. § 16-8-2**, for that the said accused, in the County of Fulton and the State of Georgia, on or about September 23, 2020, unlawfully did take money of a value exceeding \$24,999.99, to wit, \$30,503.18, further described as the funds transferred by wire number 20200923-00010626, the property of Asset Living, with the intention of depriving the owner of this property, contrary to the laws of said State, the good order, peace, and dignity thereof.
