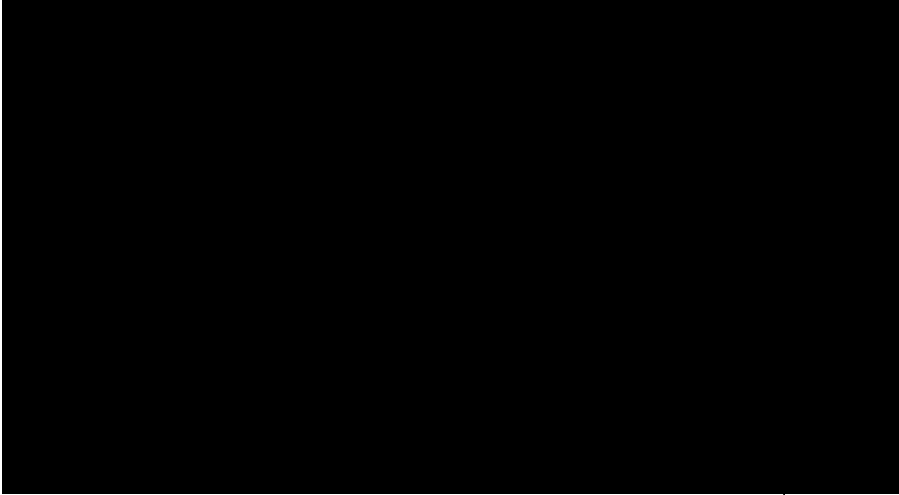

and the Grand Jurors aforesaid, in the name and behalf of the citizens of Georgia, do charge and accuse **CHIQUILLE “SANTANA” BELL** with the offense of **False Report of a Crime, in violation of O.C.G.A. § 16-10-26**, in that the said accused, in said County of Fulton and State of Georgia, on or about the 1st day of August, 2023, did willfully and knowingly give and cause a false report of a crime to a law enforcement officer and agency by falsely reporting a vehicle stolen, contrary to the laws of said State, the good order, peace, and dignity thereof;
