**PETITION TO RESTRICT CONVICTION**  
**PURSUANT TO O.C.G.A. § 35-3-37(j)(6)**

I.

Having been convicted of an offense or offenses and sentenced while being a victim of an offense of trafficking under O.C.G.A. § 16-5-46, this petitioner moves for the restriction of such conviction pursuant to O.C.G.A. § 35-3-37(j)(6).

II.

The petitioner prays that if the prosecuting attorney consents in writing to the restriction of such conviction or fails to respond to this petition within 30 days of service, the court imposing the conviction and sentence, without notice or hearing, shall issue an order restricting the conviction and sentence and also issue an order restricting access to criminal history record information for such offense or offenses, pursuant to O.C.G.A. § 35-3-37(j)(6).

III.

If the prosecuting attorney objects in writing to the petition, the petitioner prays that the court hold a hearing within 90 days of the filing of this petition to hear evidence or make a determination upon the pleadings or record, pursuant to O.C.G.A. § 35-3-37 (j)(6)(D).

IV.

The following are included as Exhibits to demonstrate the Petitioner's status as a victim of an offense of trafficking under O.C.G.A. § 16-5-46 at the time of the offense(s):

Record(s), certification(s) or eligibility letter(s) from federal, state, tribal or local proceeding(s)
