CITATION AFFIDAVIT

Personally came Special Agent Clint Thomas with Georgia Bureau of Investigation, a certified peace officer of the State of Georgia, who on oath says that to the best of his personal knowledge and belief, Jenna Garland did, on March 7, 2017, in Fulton County, Georgia, commit the offense of **VIOLATION OF THE OPEN RECORDS ACT**, in violation of **O.C.G.A. § 50-18-74(a)**, a misdemeanor under the laws of the State of Georgia, in that said accused on the above stated date, did knowingly and willfully violate the provisions of Article 4 of Chapter 18 of Title 50 of the Official Code of Georgia Annotated, commonly known as the Open Records Act, by knowingly and willingly attempting to frustrate the access to records not subject to exemption from this article by intentionally making such records difficult to obtain and review, to wit: said accused instructed the Director of Communications for the City of Atlanta Department of Watershed Management in response to an open records request for billing, payment, and usage records for 3430 Estes Drive from WSB-TV to said Department received on or about March 7, 2017, to “[d]rag this out as long as possible [a]nd provide information in the most confusing format available.”
