INTERLOCUTORY INJUNCTION ORDER

This matter is before the Court on Plaintiff's Motion for Temporary Restraining Order and Interlocutory Injunction and Defendants' Motion to Dissolve or Modify the Temporary Restraining Order. Upon consideration of the motions, the submissions of the parties and argument presented at the August 13, 2013 hearing attended by counsel for all parties and at which Defendants Western Sky Financial, Inc. and Martin A. Webb appeared specially through counsel while preserving their jurisdiction, service and venue objections, the Court hereby ORDERS that:

(1) Defendants Western Sky Financial, LLC, Martin A. Webb, CashCall, Inc., and Delbert Services Corporation (collectively, "Defendants"), along with their affiliates, officers, agents, directors, employees, successors, assigns, and any person or entity acting under the actual direction or control of Defendants, are enjoined from engaging in any business, in whatever form transacted, including

but not limited to by mail, electronic means, the Internet, or telephonic means, that consists in whole or in part of making, offering, arranging, or acting as an agent in the making of unsecured loans of \$3,000.00 or less in the State of Georgia; and

Sky Financial, LLC nor Martin A. Webb currently own title to the loan agreements or promissory notes at issue in this action, Defendants CashCall, Inc. and Delbert Services, along with their affiliates, officers, agents, directors, employees, successors, assigns, and any person or entity acting under their actual direction or control, are enjoined from selling, assigning, or otherwise transferring to any third party the rights (including servicing rights) to any loan agreement or promissory note for an unsecured loan of \$3,000.00 made to any person residing in the State of Georgia. Nothing stated herein shall prevent Defendants CashCall, Inc. and Delbert Services from servicing the loan agreements and promissory notes at issue in this action, including, without limitation, marking such notes paid, satisfied and/or canceled when the underlying obligations are fully repaid.

This Order shall remain in place until the Court enters a final judgment in this action or otherwise dissolves or modifies the Order. This Order supersedes the Court's Temporary Restraining Order dated August 5, 2013 that, except as set forth above, has been dissolved..
